Nyström M -HSIC

- Motivation:
 - HSIC (a.k.a. distance covariance): popular dependency measure, various applications.
 - Bottleneck: quadratic runtime.
 - Existing speedup: $M = 2$ components, no guarantees.
- Contributions ($M \geq 2$):
 - Improved runtime: $\mathcal{O}(n^2)$ to $\mathcal{O}(n^{3/2})$,
 - convergence rate: $\mathcal{O}_p\left(\frac{1}{\sqrt{n}}\right)$.
- Experiments: causal discovery, dependency testing of media annotations.
